### Driver Education Parent/Guardian and Student Information

- Students and Parents MUST read the information below.
- Parent/Guardian Signature Form is required for Registration

### Parents please note:

- All tuition and fees must be current with the school's bursar for your child to register for Driver's Ed
- Cost of Driver's Education Program: **\$475.00**
- Money Order ONLY
- Fee for Driver's Education must be paid in full on the day of registration
- Students Need to be 16 years of age by October 15th

### Phases of the Program

#### "Behind the Wheel" - Part 1

- Hands-On experience with a licensed Driver Education teacher

#### "Learning the Laws" - Part 2

- Lecture class: Rules of the Road, DWI - laws and consequences, Insurance Information

### Fall Program Dates

September 2017 - February 2018 - All classes, in the car and lecture, are not **held** during Christmas vacation week. The course completes in January 2018

### Spring Program Dates

February 2018 - June 2018 - All classes, in the car and lecture, are not **held** during Easter vacation week. The program completes in June 2018.

### Summer Program Dates

July 2018-August 2018

**\*\*\* Proper classroom behavior is required. All actions and interactions with the teachers and students have the same rules as the school day.**

**\*\*\* Any excessive absences, more than the allowed amount above, the fees paid for Driver's Education are NON-REFUNDABLE.**

**\*\*\* Students are NOT allowed the use of cell phones (texting or talking) or ANY electronic device in the classroom for Lecture, or in the car for Behind the Wheel lessons.**

All cell phones, iphones, ipods, etc. **MUST** be **OFF** for driving lesson or lecture class.

All the time spent in the driver education car is for a **LEARNING EXPERIENCE**.

All the students in the car can learn from the correct and incorrect actions done by the driver, while they are in the backseat **observing**.

### New York State Laws:

**Please read carefully below. Many laws have changed in the past 6 months.**

Parents are **NOT** allowed to practice driving with their children.

- The law states that you **must** have a **Dual Brake Vehicle** and a **Driver Education /Driving School License** to practice driving with an unlicensed/permit driver in all five boroughs. (You must be 18 to practice the "old Way", with a licensed driver)
- A **New York Permit** is **NOT** accepted in other states to drive, you must be a resident of that state.

### **As of February 22, 2010:**

- If you are 16 years old, and would like to take a road test before your 17<sup>th</sup> birthday, you must have the 3 items below:
- Hold a permit for 6 months from the date it was issued. For example, if you let your permit on 9/24/2010, you can take your road test after 3/24/11.
- Form MV 262 With Parent Signature - which will be given to you by your In-Car Driving Instruction.
- For MV 285 - you will receive this when you have completed Driver's Education. this will be mailed to you.

**DRIVING IS A LARGE RESPONSIBILITY,**

The privilege of driving comes with maturity and a full understanding of the Laws and Rules of the road along with proper skills behind the wheel.
